On June 3, 1999, my kids were four and two years old. I had left the Children's Inn after twelve years to start this new endeavor with the SD Network. There was no official office and only one very part-time staff. The Network's membership consisted of fourteen agencies and was growing rapidly. With the amazing work of many advocates, law enforcement, and others, the Network became a strong statewide collaboration.

I just celebrated my 22nd year with the Network and now my kids are adults. My oldest child just finished a Masters' degree at Cornell University and is starting the PHD while working as a research assistant. My second child just graduated from Dakota State University and is currently working at Hy-Vee in Sioux Falls. The Network has a beautiful and spacious Sioux Falls office suite with twelve offices for staff and four for interns. Our conference room is large enough to hold a membership meeting which is usually around 50-60 in attendance. Desiree works primarily out of her home office in Yankton, and Tanya is stationed in Pierre. On July 1st, the Network will be opening a new office in Rapid City. The suite has five offices and a large open area, and the office building is located behind Working Against Violence, Inc. We will be hiring staff for the West River office very soon. The membership has grown to over seventy agencies. We love the partnerships and welcome new projects. How can we make sure that all victims, survivors, and their families receive the help that they need? To do so, we need to truly understand the inequities and barriers faced by many. The bills signed into law during the 2021 Legislative Session will go into effect July 1st, 2021. There may have been some bills that already went into effect due to an emergency clause and/or other bills still in discussion. Here are just a few bills that may impact your work with victims and offenders; these bills will be effective July 1st.

·SB 102 will protect voter registration information for certain voters (victims of violence with protection orders and/or residing or receiving assistance from a crisis shelter).

·SB 148 will establish the crime of torture of a human trafficking victim.

·HB 1080 will increase the enhanced penalty for simple assault.

·HB 1081 will increase the penalty for protection orders violations.

·HB 1096 will provide a penalty for sexual contact with a minor by a person holding a position of authority.

·HB 1204 will revise criminal provisions regarding certain visual recordings or photographic devices.

(Cont.)victim advocacy training modules development; addressing the intersection of violence and addiction; development of sexual assault response team protocols; and providing multi-lingual victim services. It is my honor to work with our tribal partners and experience their culture and traditions.

### **Grants Project Specialist**


I have an amazing partner; Nick and we have a handsome chocolate lab (Dakota) and cat (Henry).

Rural Project: This project provides funding for eleven, part-time rural advocates to cover 42 rural counties in South Dakota. This includes providing outreach, community education, and services to victims/survivors of domestic violence, sexual assault, and human trafficking. This also includes building, supporting, and maintaining Sexual Assault Response Teams (SARTS).

Rape Prevention Education (RPE): Under the RPE funding, The Network coordinates a Sexual Violence Prevention Tribal Advisory Group. The Tribal Advisory group has meet quarterly over the past year. This group gathers to discuss sexual violence prevention in tribal communities and engaging Native Americans in urban areas in sexual violence prevention. Topics of past meetings include engaging men in sexual violence prevention, and overviews of the current sexual violence prevention programming.

Avera SANE: The SD Networks role on the Avera SANE project is to assist Avera in connecting E-SANE locations to local victim service resources.

Coalition Funding: The coalition funding provides for more culturally specific outreach and technical assistance to victim service programs.

CTAS: This funding provides transitional housing and an additional advocate to provide culturally informed services in the Flandreau area. This grant funding is ending Fall 2021.

UNL/CDC - Youth Voices in Prevention: This project is a youth-led sexual violence prevention project with a research component, based in Rapid City, SD. Although, the project specific funding is ending, the programming with youth leaders is continuing in Rapid City through the amazing work of the project's partners.

2021Visionary Voice Award

NSVRC offers the Visionary Voice Awards, in conjunction with Sexual Assault Awareness Month each April, to recognize the creativity and hard work of individuals around the country who have demonstrated outstanding work to end sexual violence. Each year, state, territory, and tribal coalitions select an outstanding individual to nominate for the awards. Nominees may be partners from a local community or other outstanding individuals that have worked to end sexual violence.

In 2015, Becky felt a push to get involved with the anti-human trafficking movement. This led her to get involved with Call to Freedom, a faith-based organization in South Dakota working with victims of human trafficking. Later that year, Becky had an encounter with a young girl named Marissa who realized she was potentially a trafficking victim who was re-recruited. This interaction launched a deep desire for Becky to become even more involved, so she filed for Call to Freedom to become its own 501c3 organization. Stepping out in faith, Call to Freedom opened its doors under Becky's leadership in March 2016 with no money. By 2021, the organization has grown to a staff of 21 and two offices. Today, Call to Freedom provides supportive services for victims of human trafficking and sexual exploitation by creating a strong network of frontline providers who offer safe housing, mental health counseling, medical assistance, chemical dependency, transportation, and other supportive services.
