UPDATE ON FAST & MMIP INITIATIVES

The FAST Tribal project continues to grow through partnerships with tribal partners and member agencies. FAST hosts a bi-weekly call to increase training, professional development, create space to share success, and advocate support. Part of the FAST Initiative was the creation of a crisis line. In partnership with the 211, the West River Human Trafficking Task Force, and Native Hope – the crisis line is now being expanded statewide as the Sex Trafficking and Sexual Assault Victim Hotline. The number is 1-888-352-8511 and will be listed on flyers and other informational documents being distributed in preparation of the Sturgis Bike Rallies.

The FAST Initiative recognizes the intersection between sexual violence and the Missing and Murdered Indigenous Relative issue. In partnership with South Dakota Urban Indian Health, we will be leading a support group in Pierre, beginning this fall, and hope to replicate it throughout the FAST community.

Tayna Grassel-Krietlow, FAST Coordinator at the Network, had the privilege to be invited and present on the successes of the FAST Initiative at conferences, both within South Dakota and out of state. She was asked to focus on multi-disciplinary relationships and cultural considerations when working with victims of trauma. It was Tanya's honor to share about the hard work, collaborations, and the sharing of resources being done by our agencies to ensure our most vulnerable have access to care.




LEADERSHIP & STAFF RETREAT RECAP

The week of July 17th, Network staff members and membership leaders participated in an Emotional Intelligence and Resilience training downtown Sioux Falls. Gerard Cleveland and Gregory Saville facilitated the training and covered several topics including personal and organizational resilience, cognitive learning, cognitive biases, self awareness and management, social awareness, relationship management, teaching techniques, conflict resolution, and more.



We are so grateful to have had this opportunity to learn more about how our emotions and reactions impact ourselves and others both personally and professionally.

APIP UPDATES

In 2022, House Bill 1272 became law. This legislation states that if a court placed a defendant on probation upon finding a defendant guilty for a crime involving domestic abuse, the defendant must attend domestic abuse counseling. The bill stipulates domestic abuse counseling must include "issues of power and control, accountability, emotional regulation, or cognitive work addressing errors in thinking."

Since the passage of the bill, The Network has been hard at work reaching out to providers throughout the state who are currently providing offender treatment, along with finding new providers who are interested in starting the work. The Network has also spent time researching different models of treatment to ensure best practices are being utilized in South Dakota, along with exploring trends in treatment for domestic violence offenders.



At the upcoming Domestic Violence Institute this fall, Abusive Partner Intervention Programming (APIP) will be a key focus. The conference will include presentations by local providers about their various approaches to this topic.

Kathy Burnette, MS, the Director of Clinical Services with Correctional Counseling, Inc. (CCI) will present at the conference on the cognitive-behavioral program and Moral Reconation Therapy (MRT).

Attorney Consultant and Adviser

Tracey has practiced as an attorney in the Rapid City area since she graduated from the Knudson School of Law USD in 1999. Tracey worked as an attorney with the Pennington County State's Attorney's Office for nearly 20 years. For much of that time, she zealously worked to bring justice to victims and safety to the community through her prosecutions of sexual assault, domestic violence, child abuse and homicide cases. She also served briefly as the Director of Victim's Assistance Program in Pennington County where she directly served victims of crime supporting them through the criminal justice process.

Tracey is not new to the South Dakota Network. Throughout her time as a prosecutor she worked as a trainer under the STOP project, traveling across South Dakota to train law enforcement officers, prosecutors, and victim advocates about the dynamics of domestic violence and sexual assault.

through her service on its Ethics and Women in Law Committees.
She currently serves on the One Heart Board of Directors in
Rapid City, SD. Over the years Tracey has been recognized for
her work with crime victims by having been awarded the WAVI
Victim's Champion Award and the Western South Dakota Child
Protection Council's Building Strong Families Award.

Tracey will be providing victim advocates with free technical assistance and training to prepare victim service professionals to provide civil and criminal legal advocacy for victims of domestic and dating violence, sexual assault, and stalking.

New Laws Making Sex Without Consent a Felony Became Effective July 1st

On July 1, 2023, two bills became law that ensure everyone has the right to a safe and healthy sexual relationship. The State Legislature passed, and the Governor signed Senate Bill 90 and 91 which defined consent and made sex without consent a felony. As defined, consent is a person's positive cooperation in act or attitude pursuant to the person's exercise of free will. South Dakota was one of twenty-five states with no definition of consent in their state laws prior to the passage of these bills.

State Senator Tim Reed of District 7 prime sponsored SB 90 and 91 and stated, "Before these bills, if a victim said no or stop to a sexual encounter, it would not be considered rape, there had to be use of force or coercion for it to be considered rape." Both the State Senate and House of Representatives passed the bills with overwhelming support. Adding consent language to South Dakota statutes started in the 2021 session.

Everyone has the right to a safe and healthy relationship, and healthy sexuality is part of that. Consent is not something you 'get'; it is an on-going conversation with another person about what you like or do not like, what you want or do not want. Consent is respectfully discussed prior to and during sexual activity and can be changed or revoked at any time. Silence, the lack of an explicit 'no', or consent to other prior activities does not equal consent. Consent cannot be negotiated if 'no' is not a viable option, meaning if someone is coerced, manipulated, afraid to say 'no,' or otherwise forced into saying 'yes', that is not consensual.

We want to thank South Dakota Senator Tim Reed District 7 for sponsoring this important piece of legislation. It is critically important that we educate our youth and others to understand what a healthy relationship is. We need to talk about it. We do not want one more person becoming a victim of sexual violence.

ATTORNEY ASSISTANCE

Under the Justice for Families and Legal Assistance grants, The Network has contracts with the following attorneys across the state. These attorneys can provide victims of domestic violence with assistance in cases related to divorce, custody, protection orders, child support cases, victim representation on criminal matters of their perpetrator, and more.
